

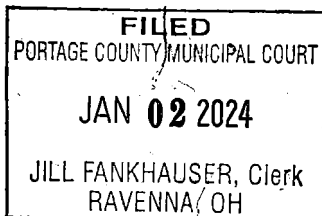

Who, being duly sworn according to law, deposes and says that on or about the 07<sup>th</sup> day of December, 2023, in the County of Portage, State of Ohio, one **BROTHERS, MIRANDA L** DOB: 12/09/1995 SSN: XXX-XX-3066

(A) Did, being the parent, guardian, custodian, person having custody or control, the person in loco parentis of **Juvenile A** (Dob:01/25/2018), a child under eighteen years of age, to wit: five (5) years of age, created a substantial risk to the health or safety to **Juvenile A** by violating a duty of care, protection or support.

To wit: **Brothers**, entrusts the care of **Juvenile A** to a male known to her and authorities as a registered Sexually Oriented Offender. This male, **Sebastian Paratore** has previously been convicted of a sexually oriented offense against a juvenile. **Juvenile A** has been observed being watched by **Paratore** alone without any other adult supervision. It is believed that **Brothers** allows **Paratore** to spend extended periods of time alone with **Juvenile A**.

Said act occurred at; **Main Street Sub Shop; 10689 Main St, Mantua Ohio, 44255** in the Village of **Mantua**, County of Portage, State of Ohio.

Said act being **Endangering children, a Misdemeanor of the First degree (M1)**.

Contrary to and in violation of Ohio Revised Code Section **2919.22 A** and against the peace and dignity of the State of Ohio.
